RULES FOR DISCIPLINE

- 1. Punctuality & regularity attendance, proper dress, a sincere effort in school assignment & gentlemanly behaviour in & outside school are always to be insisted upon & parent's full cooperation is expected at all the times.
- 2. Students are not allowed to leave the school premises without permission from the Principal/ Vice Principal.
- 3. No student is permitted to engage any of the school teachers as private tutors without the written sanction from the Principal / Vice Principal.
- 4. Students are answerable to the school authorities for their conduct in & outside. Irregular attendance habitual illness, disobedience, use of indecent language, objectionable moral behaviour, coming to school without proper school uniform & above all discourtesy & disrespect to teachers and other staff will be considered as indiscipline.
- 5. If any student is caught using unfair means during examination, strict action will be taken against him/her and he/she will be awarded zero in that subject.
- 6. The school reserves the right to take strict disciplinary action against any student if he/she violates the school rules.
- 7. Tobacco chewing, smoking and ghutka chewing is strictly prohibited in the school premises. If anyone found guilty of chewing tobacco or smoking, he/she will have to face strict punishment.

RULES FOR WITHDRAWAL

- 1. Parents are required to give at least a month's notice in writing or a month's fee in lieu of notice before the child can be withdrawn.
- 2. Those who leave school in May must in all cases pay the fee for the month of June.
- 3. Transfer certificate is issued after all the dues of the school are settled. The school also reserves the right to ask the students to leave the school on following grounds. In this case the question of charging month's fee in lieu of notice dose not arise.
 - A. Disciplinary

- B. Repeated detention in the class.
- C. Unsatisfactory progress in work.
- D. Who fails twice in the same class. (Especially if he/she is over age for that class)

GUIDELINES FOR FEE PAYMENT

Payment should be made through online payment using school website, Bank draft or cheque drawn in favour of Pranavananda International School, payable at Gurugram. No post-dated cheques will be accepted. In case any Cheque is dishonoured, a service charges of Rs. 590/- will be imposed for first time and Rs. 1000/- subsequently. Parents desirous of paying he whole year's fee in advance can do so; a month's tuition fee is discontented. For Bank details, please contact the school account office.

Please note that the fee for every quarter has to be paid as per the following schedule.

- 1. First Quarter (April-June) by 10th April.
- 2. Second Quarter (July-Sept) by 10th July.
- 3. Third Quarter (Oct-Dec) by 10th October.
- 4. Fourth Quarter (Jan-March) by 10th January.

Late fine Statement

- i. Fee can be paid monthly / quarterly.
- ii. Changes for bouncing of cheque Rs. 590/- first time and Rs. 1000/- subsequently onwards.
- iii. Fine of Rs. 10/- day will be imposed as a late fee from 11th onwards of the month in case of monthly fee or 11th onwards of the first month of that quarter in case of quarterly fee payment.
